**The giant of Chinese finance industry has invested 44 million USD (around 38 mln. Euro) to AviaAM Financial Leasing China Co., Ltd. through its relevant investment platforms. The transaction was finalized on the 27th August, 2018.**

**The bank belonging to PingAn group has already participated in one of the biggest projects of a Joint Venture by financing the purchase of a 140 million USD worth Boeing 777 aircraft. This type of aircraft is one of the biggest commercial wide-body airliners in the world powered with the world's most powerful jet engine GE90-115B turbofan that can fit over 400**
